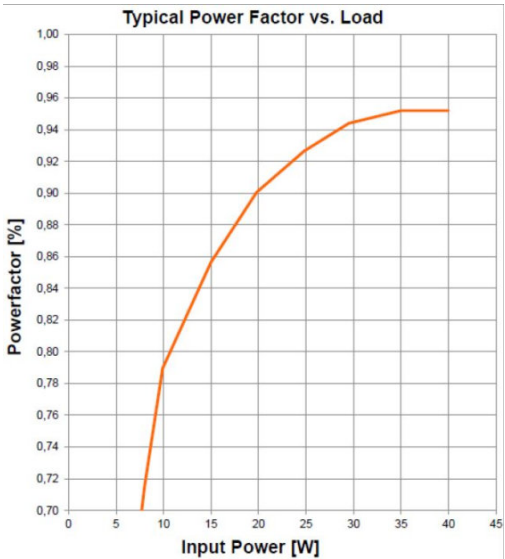

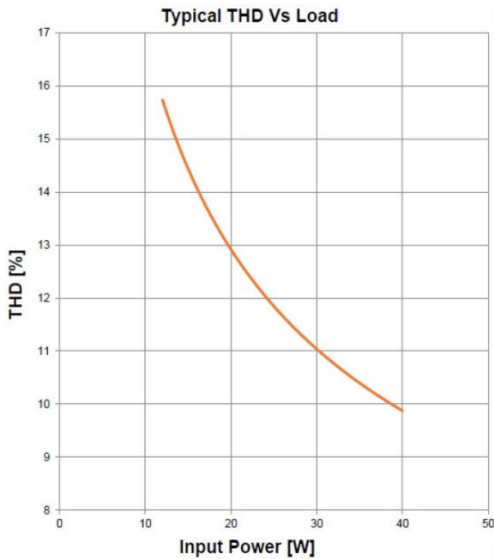
OTI DALI 35220-240400 D NFC TWL Operating Window



OTI DALI 35220-240400 D NFC TWL Typical Efficiency vs. Load (230 V 50 Hz)

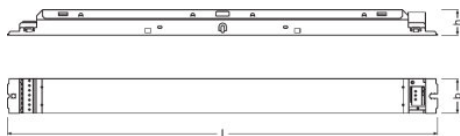


OTI DALI 35220-240400 D NFC TWL Typical Power Factor vs. Load
